Two local entrepreneurs named Overall Winners of The Entrepreneur of the Year Award; four entrepreneurs bagged subcategory awards

Singapore, 22 November 2018 – Two local entrepreneurs were conferred Overall Winners of the Entrepreneur of the Year Award (EYA) 2018 at the Award Presentation Ceremony held at The Ritz-Carlton, Millenia Singapore. Another four entrepreneurs bagged sub-category awards in Business Strategy, Social Contribution, and Innovation & Technology. The event was graced by Guest-of-Honour, Minister for Trade and Industry, Mr Chan Chun Sing.

Mr Derrick Yap Khiam Wee, Chief Executive Officer of PBA International Pte Ltd, was the **Overall Winner of the Established Entrepreneur** category. Started from humble beginnings as a hardware trading company, PBA is now a leading end-to-end supplier for robotics and industrial 4.0 solutions, focusing on human capital and R&D in the field of robotics and automation. As CEO, Mr Yap oversees 30 companies in the Group with offices in 10 countries and over 500 employees across Asia.

At the ceremony, Mr Ng Kim Wah, Chief Executive Officer of Skyfy Technology Pte Ltd, was named **Overall Winner of the New Entrepreneur** category. With a strong motivation to make a positive impact on the lives of others and innate curiosity, Mr Ng entered the fleet management industry. Skyfy Technology's software platform provides assistance to companies in terms of managing their transportation fleet more efficiently and more productively.

Co-Founder and Managing Director of Marunda Utama Engineering Pte Ltd, Ms Rachel Wong Mai Kim, was awarded the **EYA for Social Contribution in the Established Entrepreneur** category. Marunda focuses on the defence, marine and industrial segments, covering the territory of Asia to supply diesel, gas, dual fuel engines, gensets, spare parts and provide service and maintenance of mechanical and electrical machineries on board commercial, defence

and private vessels. Under Rachel's steadfast leadership, Marunda gives back to society through a vast depository of CSR initiatives, and employees are also encouraged to do their part by participating in community activities.

Mr Ryan Sumesh, CEO and Chairman of Vrobal Energy & Resources Pte Ltd, brought home the **EYA for Innovation & Technology in the Established Entrepreneur** category. Vrobal is a whollyowned local waste management and recycling company that is a leading specialist in the trading and possessing of precious and non-precious metals from waste. The company has designed a Precious Metal Recovery System that applies a methodology to recover precious metals like gold, palladium and platinum to optimal levels from waste processing.

Mr Lai Kian Ming, Roy, Founder and CEO of InfoCorp Technologies Pte Ltd, received the **EYA for Social Contribution in the New Entrepreneur** category. InfoCorp Technologies was founded in 2015 with the intention to provide blockchain-based financial solutions for agricultural countries with a high livestock population. Roy's innovative approach of utilising blockchain to prove ownership of livestock and allowing it to be used as collateral, reduced the lending risk for microfinancing institutions.

Dato' Victor Tan Jenn Chyen, CEO of Top International Holding Pte Ltd, was awarded the **EYA for Business Strategy in the New Entrepreneur** category. The company specialises in Bauxite mining in Guinea, West Africa, and Bauxite trading. Top International was also the first bauxite exporter in Malaysia to perform anchorage loading to vessels by using tug boats and barges with floating cranes.

The EYA is currently into its 30th year honouring and celebrating the achievements of local entrepreneurs. Co-organised by the Association of Small & Medium Enterprises (ASME) and Rotary Club of Singapore, the Award seeks to continue uplifting the profile of homegrown Entrepreneurs and inspire entrepreneurial success in the business community.

Mr Kurt Wee, President of ASME, said, "It's always heartening when our local entrepreneurs venture and achieve success beyond Singapore. We know they will continue to make Singapore proud. All Winners of EYA 2018 have demonstrated strong passion in their business,

ABOUT THE AWARD: QUALIFYING CRITERIA

NEW ENTREPRENEUR CATEGORY

The New Entrepreneur category aims to recognise fledging Entrepreneurs who demonstrate keen business acumen, innovation & creativity in differentiating their new businesses from the market.

The Entrepreneur must:

(A) The Participant:

- I. Has been operating the business for a period of more than 2 years but less than 7 years
- II. Is a Singaporean or Permanent Residents above the age of 18
- III. Owns at least 30% of the Company's shares (Endorsement from the Board of Directors is required for candidates with less than 30% ownership)
- (B) The Participant's Company:
 - I. Has at least 30% local equity
 - II. Must not be a listed company nor a subsidiary of a listed company
 - III. Has at least 3 years of financial statements, which must be submitted for evaluation (Companies that have been operating the business for less than 3 years may submit 2 years of financial statements.)

ESTABLISHED ENTREPRENEUR CATEGORY

The Established Entrepreneur category aims to uncover veteran businessmen who possess the tenacity and resourcefulness that brought their enterprises to success, while embracing innovation and keeping with the changing landscape and maintaining a strong foothold in the business arena.

The Entrepreneur must:

(A) The Participant:

- I. Has been operating the business for a period of 7 years and above
- II. Is a Singaporean or Permanent Residents above the age of 21
- III. Owns at least 30% of the Company's shares (Endorsement from the Board of Directors is required for candidates with less than 30% ownership)

(B) The Participant's Company:

- I. Has at least 30% local equity
- II. Must not be a listed company nor a subsidiary of a listed company.
- III. Has at least 3 years of financial statements, which must be submitted for evaluation.
